I started this year reflecting on the idea of a new decade. The connection between our organizational strategic repositioning, our new name, and this new decade had not aligned for me until I started writing this greeting. I walked into Safe Homes ten years ago with excitement, nervousness and gratitude for the opportunity to grow the ideas and experience gained in my previous professional roles in the field. Much of what was concerning then is still concerning now. While we work tirelessly towards a world free from violence and abuse, we continue to see the increased need for services and support for victims and survivors. Our programs and services have grown significantly to meet these needs, and we transformed an organization once thought to be shelter-driven into a leader within the community working to address interpersonal violence and human trafficking. We continue to demand that formal and informal systems hold abusers accountable, and commit to the on-going work to create a paradigm shift within the world that collectively works to dismantle individual and systemic forms of oppression that continue to create environments ripe for some to cause harm, abuse, and use forms of violence towards individuals and groups within our communities continues.



If we are going to dedicate our lifetime to creating a world free of abuse and violence in all its forms then we need to be Fearless!. Change is challenging no matter how rewarding the end result may be. There is a tendency for some to do what has always been done, to avoid discomfort, or the rocking of the boat. Speaking up is scary, and one runs the risk of being wrong, harmed, or worse—silenced. We, as a collective body of citizens, must all play a role when it comes to ensuring everyone has the basic human right to live free from abuse and violence in all its forms. Every few seconds in this country a victim is being abused, and victims and their children continue to die at the hands of their abusers. We are done allowing individuals and systems to place the burden of safety on the victim's shoulders. As we usher in this new decade, we look to our outside partners, friends, colleagues, and local communities to start asking: what are we going to do about it? There are systems and laws, myths and misconceptions, which only serve to embolden abusers. Educating ourselves and actively applying what we learn about the complexities of domestic violence in our roles within the community is the most vital step in stopping abuse. Whether you are an advocate, judge, lawyer, police officer, grocery clerk, or nurse: it is everyone's responsibility and it will take all of us to grow, learn, and try new approaches if we are going to stop the murders, reduce the abuse, and support children to lead healthy, happy lives.

January was **Human Trafficking and Stalking Awareness Month** and we hope you will take time to learn about the crime of human trafficking and the dangerousness of stalking. Our Anti-Trafficking team actively works to educate our community on human trafficking and the reality that it is happening right here in Orange and Sullivan counties. One in three teens in the U.S. will experience dating violence. February is **Teen Dating Violence Awareness** month and our Educators will be hosting free community workshops and special programming within schools throughout the month. Please stop by *2Alices Coffee Lounge* in Newburgh through February 24th to see the artwork created by local youth for our 6th **Annual Teen Art Contest**.

We are excited to share that in October 2019, Fearless! was awarded a grant from the **NYS Office of Victim Services** to expand victim services programming throughout Orange and Sullivan County. This award is the result of a competitive RFP that was issued over the summer in 2019. Through this grant, Fearless! has been able to expand our Risk Reduction Response program, Therapeutic Counseling, Hotline Advocacy, Education & Outreach, Youth, and Advocacy Services. This award would not have been possible without support and funding from both the Orange County and Sullivan County Department of Social Services, and other funding partners.

Additional Office Space

With the agency's growth and expansion this past October came the need to secure additional office space in Orange and Sullivan Counties. After months of work behind the scenes, we were able to not only expand our Family Justice Center in Orange County, but are thrilled to announce that as of January 2020 we will be sharing space with the **RISE** program at Catskill Regional Medical Center (CRMC) in Harris. This new space will be in addition to our office at the Sullivan County Government Center and will allow us greater flexibility in meeting the needs of victims and survivors in Sullivan County outside of traditional business hours and on holidays when government offices are closed and **FEARLESS!** is not.

Our CRMC offices will be the new home for our Sullivan-based education and outreach team, in addition to providing a comfortable space for therapeutic counseling sessions. **FEARLESS!** advocates are available at the Sullivan County Government Center during business hours, and by appointment at our new CRMC offices. 
